CALL TO ORDER

Smith called the meeting to order.

ROLL CALL

The clerk called the roll: Smith and Bennett were present and Morris, Johns, and McClure were absent.

INVOCATION

Smith gave the invocation.

PLEDGE OF ALLEGIANCE

Smith led the Pledge of Allegiance.

1. EXTENSION OF LOCAL STATE OF EMERGENCY

McCormack provided details of the recommendation to extend the local state of emergency.

(1:33 p.m.) Wanchick recommended extending the Local State of Emergency, at least until the next Board of County Commission meeting on November 1, 2016. He updated the Board on the status of the shelter, the beaches and beach clean-up, and the no-wake zone areas.

Locklear reported that there had already been 110,000 cubic yards of debris collected; he estimated that they were about halfway complete.

(1:37 p.m.) Bennett thanked Commissioner-Elect Paul Waldron for attending the meeting. Waldron commented on the devastation throughout the County.

(1:38 p.m.) McCormack informed the chair that there were not a sufficient number of Board members present for a quorum; however, as chair, he had the authority to sign an emergency proclamation extending the Local State of Emergency. He also explained that as the need lessened, the Board could choose not to further extend the local state of emergency. He said that if a future emergency arose, the Board could re-initiate at that time.


