Johns called the meeting to order.

(09/05/17 - 1 - 5:01 p.m.)

5:01 P.M. PUBLIC HEARING - ADOPTION OF TENTATIVE MILLAGE RATES & BUDGET FOR FY 2018. IN ACCORDANCE WITH SECTIONS 129.03 AND 200.065 OF THE FLORIDA STATUTES, THE BOARD OF COUNTY COMMISSIONERS (BCC) IS REQUIRED HOLD PUBLIC HEARINGS TO ADOPT ITS MILLAGE RATES AND BUDGET FOR THE NEXT FISCAL YEAR (FY). SUCH HEARINGS MUST BE HELD AFTER 5:00 P.M. IF SCHEDULED ON A DAY OTHER THAN SATURDAY. IN THE RECENTLY MAILED NOTICES OF PROPOSED PROPERTY TAXES (TRIM) BY THE COUNTY'S PROPERTY APPRAISER, THE DATE AND TIME NOTICED FOR THE REQUIRED HEARINGS IS SEPTEMBER 5, 2017, AT 5:01 P.M. THE FLORIDA STATUTES FURTHER PRESCRIBE THE SPECIFIC ORDER FOR CONSIDERATION OF SUBSTANTIVE ISSUES TO BE DISCUSSED DURING THE REQUIRED PUBLIC HEARINGS. THE FIRST SUBSTANTIVE ISSUE OF DISCUSSION MUST BE THE PERCENTAGE INCREASE IN THE COUNTY'S AGGREGATE MILLAGE RATE OVER THE ROLLED-BACK RATE NECESSARY TO FUND THE BUDGET. THE ROLLED-BACK RATE IS DEFINED AS THE AGGREGATE MILLAGE RATE THAT WOULD GENERATE THE SAME LEVEL OF PRIOR YEAR TAX REVENUES, LESS CERTAIN DEFINED ALLOWANCES (SUCH AS NEW CONSTRUCTION). DURING SUCH DISCUSSION, THE GENERAL PUBLIC SHALL BE ALLOWED TO SPEAK AND ASK QUESTIONS PRIOR TO THE ADOPTION OF ANY MEASURES BY THE BCC. THE BCC SHALL ADOPT BY RESOLUTION ITS TENTATIVE MILLAGE RATES PRIOR TO ADOPTING ITS TENTATIVE BUDGET FOR FY 2018. ADDITIONALLY, THE BCC IS REQUIRED TO ESTABLISH A DATE, TIME, AND PLACE TO CONDUCT PUBLIC HEARINGS ON THE FINAL MILLAGE AND BUDGET ADOPTION FOR FY 2018. IT IS RECOMMENDED THAT THE BCC ESTABLISH SEPTEMBER 19, 2017, AT 5:01 P.M. IN THE COUNTY AUDITORIUM, TO CONDUCT SUCH **HEARINGS** 

Jesse Dunn, Director of the Office of Management and Budget, provided background on the budget process and presented a timeline, via PowerPoint. He explained the procedures prescribed by Florida Statute 200.65, which included the following:

- 1. DISCUSSION OF THE PERCENTAGE INCREASE OVER THE ROLLED-BACK RATE:
  - The taxing authority was stated as St. Johns County.
  - The rolled-back millage rate was stated as 6.9502 mils.
  - The first substantive issue discussed was the percentage increase from the rolled back rate, which was 4.34%
  - The proposed aggregate millage rate was stated as 7.2518 mils.

- (5:22 p.m.) Pam Linder, 11 Pine Street, spoke in support of body cameras, noting incidents in Daytona Beach, and read the names from petitions, *Exhibit A*.
- (5:25 p.m.) Sharyn Brooks, 2824 Kings Road, spoke in support of funding for library services.
- (5:28 p.m.) Lisa Lloyd, 132 Surfside Avenue, spoke in support of funding for body cameras.

- (5:34 p.m.) Morris spoke on the budget process, including a timeline of events; a summary of the Board's decisions; the utilization of reserves; and noted specific details and ramifications of those decisions.

# 3. ADOPT PROPOSED MILLAGE RATE RESOLUTION

(5:45 p.m.) Motion by Smith, seconded by Johns, carried 5/0, to adopt Resolution 2017-294, approving the proposed millage rates for Fiscal Year 2018, of the Board of County Commissioners of St. Johns County, as follows:

- General Fund millage rate of 5.1000
- County Transportation Trust Fund millage rate of 0.7500
- County Health Unit Trust Fund millage rate of 0.0171
- Fire District Fund millage rate of 1.4700
- Vilano Street Lighting District millage rate of 0.0500
- St. Augustine South Street Lighting District millage rate of 0.2100
- Summerhaven MSTU millage rate of 8.5000
- The St. Johns County aggregate millage of 7.2518

(5:47 p.m.) Johns referenced page 15 of tentative budget book, noting that the library services' budget had increased from the FY17 budget and spoke to the misinformation regarding the library's budget and hours being cut. Additionally, he stated that the Board does not have authority to change the library hours, the decision to cut hours would be made by the Director of Library Services, and there had been no directive as to how the money, hours, or manpower was managed. Dunn responded that the FY18 proposed budget did not show a reduction in funding for Library Services.

(5:50 p.m.) Debra Rhodes Gibson, Director of Library Services, stated that the users of the library were passionate and that there were no anticipated reductions in hours. She mentioned the need to restore the hours that were lacking at the Main Branch and the Bartram Trail Branch, and that additional staff had been requested, which had not

been included in the proposed budget, which led to the misinformation. Johns requested the directors, who have more details than that of the Board, correct the misinformation. He noted it was the department director's responsibility to convey accurate information to the people in which they were providing services.

(5:54 p.m.) Morris continued with the budget timeline, his view on the recommended budget, and a bottom-up approach. Discussion ensued on the increase in funding for library services, the utilization of reserves, and the estimated amount of revenue from taxes.

### 4. ADOPT PROPOSED BUDGET RESOLUTION

(6:01 p.m.) Motion by Smith, seconded by Dean, carried 5/0, to adopt Resolution No. 2017-295, approving the proposed Fiscal Year 2018 budget of the Board of County Commissioners of St. Johns County, Florida, using the certified taxable value of \$23,858,170,140, generating an estimated \$173,014,806 in taxes, and resulting in a total budget of \$731,567,800
