Smith called the meeting to order and made opening comments regarding remote public participation.

The clerk called the roll, and all Board members were present, with Dean participating remotely.

Chaplin Kelly Kemp, St. Johns County Sherriff's Office, led the invocation.

Blocker led the Pledge of Allegiance.

1. EMERGENCY MANAGEMENT UPDATE

Hunter S. Conrad, County Administrator, provided an update on St. Johns County's response to COVID-19, including available asymptomatic testing. He noted that all St. Johns County parks had been open, and there was a lag in the Florida Department of Health's Dashboard. He explained the timing between phases one and two; and noted the Small Business Care Package would be discussed during the regular Board of County Commissioner's meeting.

(8:42 a.m.) Linda Stoughton, Emergency Management Director, provided an update on the Emergency Operations Center's (EOC) response to COVID-19. She reported on the distribution of personal protective equipment, and the distribution of shelf-stable meals.

(8:44 a.m.) Blocker questioned Conrad on the reopening of youth activities. Conrad explained Governor Ron Desantis' Order on Phase II, and stated that groups still needed to be less than ten persons.

(8:47 a.m.) Tom Reynolds, 50 Brigantine Court, spoke on his concerns with unemployment and the lack of rental assistance programs in the county.

(8:50 a.m.) Sherry Badger, 2772 S. Collins Avenue, spoke on drainage concerns on Collins Avenue, and referenced information on easements, *Exhibit A*.

(8:54 a.m.) Jade Brown, 1897 Village Glen Drive, President of Creeks Baseball Club, spoke in support of reopening sports activities.

(8:56 a.m.) Brandon Batelli, 213 Torwood Drive, spoke in support of reopening sports activities, and questioned if there was a plan in place that addressed social distancing.

(8:58 a.m.) Carol Mancuso, 206 Amistad Drive, spoke on wheelchair beach access and requested the beaches be reopened for vehicular access.
