Proceedings of a special meeting of the Board of County Commissioners (BCC) of St. Johns County, Florida, held in the auditorium at the County Administration Building, 500 San Sebastian View, St. Augustine, Florida.

Smith called the meeting to order. He provided opening comments regarding remote public participation.

(09/08/20 - 1 - 5:03 p.m.) ROLL CALL

The clerk called the roll. Commissioners Smith, Johns, and Dean were present. Commissioners Blocker and Waldron participated remotely.

(09/08/20 - 1 - 5:03 p.m.) INVOCATION

Johns led the invocation.

(09/08/20 - 1 - 5:03 p.m.) PLEDGE OF ALLEGIANCE

Dean led the Pledge of Allegiance.

(09/08/20 - 1 - 5:04 p.m.)

1. PUBLIC HEARING - 5:01 P.M. PUBLIC HEARING - ADOPTION OF TENTATIVE MILLAGE RATES & BUDGET FOR FY 2021. IN ACCORDANCE WITH SECTIONS 129.03 AND 200.065 OF THE FLORIDA STATUTES, THE BOARD OF COUNTY COMMISSIONERS (BCC) IS REQUIRED TO HOLD PUBLIC HEARINGS TO ADOPT ITS MILLAGE RATES AND BUDGET FOR THE NEXT FISCAL YEAR (FY). SUCH HEARINGS MUST BE HELD AFTER 5:00

P.M., IF SCHEDULED ON A DAY OTHER THAN SATURDAY. IN THE RECENTLY MAILED NOTICES OF PROPOSED PROPERTY TAXES (TRIM) BY THE COUNTY'S PROPERTY APPRAISER, THE DATE AND TIME NOTICED FOR THE REQUIRED HEARINGS IS SEPTEMBER 8, 2020, AT 5:01 P.M. THE FLORIDA STATUTES FURTHER PRESCRIBE THE SPECIFIC ORDER FOR CONSIDERATION OF SUBSTANTIVE ISSUES TO BE DISCUSSED DURING THE REQUIRED PUBLIC HEARINGS. THE FIRST SUBSTANTIVE ISSUE OF DISCUSSION MUST BE THE PERCENTAGE INCREASE IN THE COUNTY'S AGGREGATE MILLAGE RATE OVER THE ROLLED-BACK RATE NECESSARY TO FUND THE BUDGET. THE ROLLED-BACK RATE IS DEFINED AS THE AGGREGATE MILLAGE RATE THAT WOULD GENERATE THE SAME LEVEL OF PRIOR YEAR TAX REVENUES LESS CERTAIN DEFINED ALLOWANCES (SUCH AS NEW CONSTRUCTION). DURING SUCH DISCUSSION, THE GENERAL PUBLIC SHALL BE ALLOWED TO SPEAK AND ASK QUESTIONS PRIOR TO THE ADOPTION OF ANY MEASURES BY THE BCC. THE BCC SHALL ADOPT, BY RESOLUTION, ITS TENTATIVE MILLAGE RATES PRIOR TO ADOPTING ITS TENTATIVE BUDGET FOR FY 2021. ADDITIONALLY, THE BCC IS REQUIRED TO ESTABLISH A DATE, TIME, AND PLACE TO CONDUCT PUBLIC HEARINGS ON THE FINAL MILLAGE AND BUDGET ADOPTION FOR FY 2021. IT IS RECOMMENDED THAT THE BCC ESTABLISH SEPTEMBER 22, 2020, AT 5:01 P.M., IN THE COUNTY AUDITORIUM, TO CONDUCT SUCH HEARINGS. Jesse Dunn, Director, Office of Management & Budget, presented the details of the tentative budget, via PowerPoint, and referenced the Tourist Development Tax (TDT) increase, *Exhibit A*. He stated that the rolled-back millage rate was 6.8470, the tentative aggregate millage rate 7.2496, and the percentage increase over the rolled-back rate was 5.88%.

(5:27 p.m.) Felix Bueno, 251 Suzanne Circle, spoke on his concerns with the increase in restricted and unrestricted reserves; and suggested reallocating the money to lower fees, such as planning fees, animal adoption fees, public defender fees, and ambulance fees.

(5:30 p.m.) Smith recommended a rolled-back millage rate due to the strain on the economy and the county's unemployment rate, which was 7.9% for July, and an increase in gross taxable property values. He stated that from 2016 to 2020 just values increased \$12,696,113,678, taxable values increased \$9,481,095,413, and gross taxable values increased by \$69,563,745. Discussion ensued on a rolled-back millage rate that would not include new construction.

(5:38 p.m.) Motion by Dean, seconded by Blocker, failed 2/3, via roll call vote, with Waldron, Smith, and Johns dissenting, and Waldron and Blocker participating remotely, to adopt the tentative millage rate resolution, approving the fiscal year 2021 tentative millage rates for fiscal year 2020, as set by the Board of County Commissioners of St. Johns County, as outlined, with an aggregate millage rate of 7.2496: General Fund 4.9500; County Transportation Trust Fund 0.9000; County Health Unit Trust Fund 0.0171; Fire District, Countywide except City of St. Augustine, 1.4700; St. Augustine South Street Light District 0.2100; Vilano Street Lighting District 0.05; Summerhaven MSTU 8.5; Coastal Highway MSTU 0.5000; Ponte Vedra Beach Dune & Beach Restoration MSTU 0.0; Serenata Beach Dune & Beach Restoration MSTU 0.0; with an aggregate millage rate of 7.2496 mils; rolled-back rate 6.8470 mils.

(5:41 p.m.) Dunn presented the rolled-back millage rates, *Exhibit B*.

(5:46 p.m.) Motion by Smith, seconded by Johns, carried 5/0, via roll call vote, with Blocker and Waldron participating remotely, to adopt Resolution No. 2020-342, approving the fiscal year 2021 tentative millage rates for fiscal year 2020 as set by the Board of County Commissioners of St. Johns County: General Fund 4.6537 mils; County Transportation Trust Fund 0.8444 mils; County Health Unit Trust Fund 0.0160 mils; Fire District, Countywide except City of St. Augustine, 1.3813 mils; St. Augustine South Street Lighting District 0.1968 mils; Vilano Street Lighting District 0.0473 mils; Summerhaven MSTU 7.3392 mils; Coastal Highway MSTU 0.5000 mils; Ponte Vedra Beach Dune & Beach Restoration MSTU 0.0 mils; S. Ponte Vedra Dune & Beach Restoration MSTU 0.0 mils; with an aggregate millage rate of 6.8130 mils; rolled-back rate 6.8470.
