1. CONSTITUTIONAL OFFICERS' FISCAL YEAR 2022 BUDGET PRESENTATIONS - ST. JOHNS COUNTY CLERK OF THE CIRCUIT COURT AND COMPTROLLER (COC) AND ST. JOHNS COUNTY SUPERVISOR OF ELECTIONS. PRESENTATION OF THE CONSTITUTIONAL OFFICERS' TENTATIVE BUDGETS FOR FISCAL YEAR 2022. UNDER F.S. 129.03(2), ON OR BEFORE JUNE 1 OF EACH YEAR, CONSTITUTIONAL OFFICERS SHALL SUBMIT TO THE BOARD OF COUNTY COMMISSIONERS (BCC) A

TENTATIVE BUDGET FOR THEIR RESPECTIVE OFFICES FOR THE ENSUING FISCAL YEAR. SINCE THE TAX COLLECTOR IS FEE-BASED, IT IS NOT REQUIRED FOR THE TAX COLLECTOR'S BUDGET TO BE SUBMITTED TO THE BCC AT THIS TIME. EACH CONSTITUTIONAL OFFICER WILL MAKE A BRIEF ORAL PRESENTATION TO THE BCC RELATIVE TO THEIR RESPECTIVE TENTATIVE BUDGET. THE TENTATIVE PRESENTATION ORDER WILL BE: 1) CLERK OF THE CIRCUIT COURT AND COMPTROLLER BRANDON PATTY; AND 2) SUPERVISOR OF ELECTIONS VICKY OAKES. Jesse Dunn, Director, Office of Management and Budget, opened the item.

#### Clerk of Court and Comptroller Brandon J. Patty:

(9:21 a.m.) Brandon J. Patty, Clerk of the Circuit Court and Comptroller, presented budget details, via PowerPoint. He noted increases to personnel services (full-time equivalents), under the Comptroller's Office combined budget and the Court Subsidy budget. Additionally, he spoke on the community effort in attaining an additional county judge in St. Johns County.

#### Supervisor of Elections Vicky Oakes:

(9:24 a.m.) Vicky Oakes, Supervisor of Elections, presented budget details, via PowerPoint. She reviewed the following: 1) the November 3, 2020, presidential general election; 2) office history; 3) the redistricting project, including timelines; and 4) the Fiscal Year 2022 budget request. She noted that there was a 3.67 percent budget increase.

(9:37 a.m.) Discussion ensued on security grant funding from the State, including legislative activity regarding voting security.

(9:40 a.m.) Ed Slavin, P.O. Box 3084, spoke on the 2020 election, the addition of polling locations, a suggested timeline for constitutional budget presentations, and the COC inspector general's budget.

(9:43 a.m.) Tom Reynolds, 50 Brigantine Court, spoke about the supervisor of elections office, including office expansion; COC wages; and Clerk Patty resigning as the chairman of the St. Johns County Republican Party.

(9:46 a.m.) Rebecca Lavie, Senior Assistant County Attorney, entered the meeting.

HURRICANES MATTHEW AND IRMA EMERGENCY BEACH BERM PROJECT 2. UPDATE. BOTH HURRICANE MATTHEW AND HURRICANE IRMA INFLICTED SEVERE IMPACTS TO ST. JOHNS COUNTY, RESULTING IN A DECLARATION PRESIDENTIAL FOR FEDERAL ASSISTANCE CATEGORIES A THROUGH G OF FEMA'S PUBLIC ASSISTANCE PROGRAM. AS PART OF THE RECOVERY PROCESS, THE COUNTY SUBMITTED A CATEGORY B EMERGENCY BEACH BERM PROJECT FOR BOTH STORMS. FEMA HAS PROVIDED A CONDITIONAL APPROVAL, WITH COMPLETION DATE OF DECEMBER 31, 2021

Joseph Giammanco, Director, Emergency Management, presented details on the beach berm project, via PowerPoint. He noted that the Federal Emergency Management Agency's (FEMA) conditional approval reduced the project completion timeline from June 30, 2022, to December 31, 2021. He reviewed the FEMA project worksheet estimated cost, including project reimbursement; eligible project areas; variable cross sections (berm

height/construction); temporary easement acquisition; project locations, easements, and cost; proposed project details; two proposed intermediate staging areas; proposed access points; environmental and cultural considerations; community considerations; and proposed project duration per sections/areas, via PowerPoint. Additionally, he provided a project summary and contact information, via PowerPoint.

(10:11 a.m.) Discussion ensued on eligible properties and areas, including easement participation, how to count condo associations, and eliminating specific areas/sections; The South Anastasia Communities Association's (SACA) environmental impact concerns; community meetings; project timelines, including extension details; contractor/FEMA liability to damage sustained while under construction; and access points to the north. Additional comments provided by Damon Douglas, Coastal Manager, on easement participation and counting condo associations.

(10:32 a.m.) Ann Taylor, 1365 North State Road 206 East, read a letter from SACA to the Board of County Commissioners, regarding the following concerns: 1) received public information on granting easements; 2) the need for renourishment in Crescent Beach; 3) the proposed timeline, regarding sea turtle nesting; 4) project cost; 5) the FEMA project completion date; and 6) the environmental impacts to the Anastasia beach mouse, *Exhibit A*.

(10:36 a.m.) Ed Slavin, P.O. Box 3084, responded to Taylor's public comment regarding granting easements for dune renourishment. Additionally, he spoke on the need for a national environmental policy and the need for a St. Augustine national historical park and national seashore designation.

(10:39 a.m.) Tom Reynolds, 50 Brigantine Court, responded to Taylor's public comment regarding granting easements for dune renourishment. Additionally, he spoke about the County seeking assistance with filing federal permits, and the lack of need for renourishment in the Butler, Crescent, and Summer Haven Beach areas.

(10:43 a.m.) Mary Ellen Darretta, 941 Ponte Vedra Boulevard, spoke in opposition to the proposed project, regarding the lack of information provided to residents about the temporary easements, beach safety for the elderly, the environmental impact, and damage to seawalls.

Wanda Forrest, North Florida Transportation Planning Organization (TPO), introduced Elizabeth DeJesus, North Florida TPO.

(11:15 a.m.) DeJesus provided the details of the TPO's TIP presentation, via PowerPoint. She reviewed the Transportation Improvement Program (TIP) plan responsibilities; scheduled public meetings; and approval of the final TIP plan, which included a list of proposed St. Johns County projects.

(11:19 a.m.) Lisa McGlynn, 703 Pinehurst Place, appointed to the North Florida Transportation Advisory Committee, voiced her frustrations of the committee not being able to speak with each other. She spoke in opposition of the resurfacing project on State Road (SR) 207, stating that it was slated to be widened within the next two years. She also spoke on a long-range plan which included bicyclists and pedestrians in the transportation plan for the County.

(11:22 a.m.) Ed Slavin, P.O. Box 3084, spoke on public transportation.

(11:26 p.m.) Dean commented on the concerns addressed by McGlenn regarding holding meetings for the Transportation Advisory Committee. McCormack responded that the appointed advisory committees must follow the Sunshine Law and provided the Sunshine Law requirements. Dean also asked Phong Nguyen, Transportation Planning Manager, to provide additional comments on the timing and details of the State Road (SR) 207 project. (11:47 a.m.) Ed Slavin, P.O. Box 3084, spoke in support of the proposal and questioned why Ponte Vedra was an MSD and not a city. Additionally, he questioned why Nocatee was not a city and requested a study in terms of long-range planning.
