**CRIMINAL TRAFFIC  
PLEA OF NOLO CONTENDERE**

**Pursuant to s. 318.14 (10)(a), this form/plea should only be used if at the time you received your criminal citation you were:**

1. Operating a motor vehicle without a valid driver's license in violation of the provisions of s. 322.03, or operating a motor vehicle with a license that has been suspended for failure to appear.
2. Operating a motor vehicle without a valid registration in violation of s. 320.07, or s. 320.131
3. Operating a motor vehicle with a license that has been suspended under s. 322.245 for failure to pay any financial obligation as provided in s. 322.245; however, this subparagraph does not apply if the license has been suspended pursuant to s 322.245(1).

You must present proof of compliance prior to the scheduled court appearance date for criminal citations. Proof of compliance shall consist of a valid, renewed, or reinstated driver's license or registration.

3. I hereby enter my plea of Nolo Contendere to the charge, a second-degree misdemeanor, and provide proof of compliance and payment as shown below. I understand that adjudication will be withheld.
4. I understand that I waive the right to be tried within ninety (90) days as provided by law and Rule 3.191 (Speedy Trial), Florida Rules of Criminal Procedure.
